"Water is Life" is the theme of the 2008 Poster Contest.



How Are Contest Winners Selected?

Your local **Soil Conservation District** will select winners and award prizes in each District. First place District level winners will be advanced to the state level competition. See page 2 for Local Rules.

The **NJ Association of Conservation Districts (NJACD)** oversees the **State Competition**. Cash prizes are awarded to 1st, 2nd, and 3rd place winners in each of four grade-categories of competition (*Grades 2-3, 4-6, 7-9 and 10-12*).

Water is Life!

Water is part of our every day life. We drink it; we need it to grow our food. You can study about the water cycle, groundwater, sources of drinking water, watersheds, drought, flooding and other water-related topics. Then create an entry for the 2008 Conservation Poster Contest.

Who can participate?

The NJ Conservation Poster Contest is open to all New Jersey students in grades 2 to 12. Community youth groups, home schooled students, and all public, private and parochial school students are invited to participate.

Why participate?

- You can help spread the word about the importance of water conservation
- You can show how conservation can make a difference for all of us.
- You can win valuable prizes and recognition for your school.

NJACD 2008 Cash Prizes for Statewide Competition :

1st - \$200 Cash Award

2nd - \$100 Cash Award

3rd - \$50 Cash Award

The **New Jersey Grand Champion** will be selected from one of the first place state competition posters. The Grand Champion poster will be reproduced on folders for use at conservation education events throughout the State in 2008.

First place state winners will be advanced to the **national level competition** in December.



The New Jersey Conservation Poster Contest is sponsored by your local Soil Conservation District along with the New Jersey Association of Conservation Districts (NJACD) and co-sponsors including the NJ Department of Agriculture - State Soil Conservation Committee, USDA, Natural Resources Conservation Service, and Rutgers Cooperative Research and Extension

PROGRAM GUIDELINES

Poster Contest Rules

These rules must be followed for your poster to be accepted by your local Conservation District. Entries that do not conform to the rules will not be judged.

1. Clearly print your name and county on the back of your poster AND tape the completed entry form to the back of your poster.
2. Include a one to three sentence explanation of your poster, neatly written on a 3" x 5" or 4" x 6" index card. Be sure to also include your name and county on the card.
3. Contest theme must appear somewhere in your poster. *"Water is Life."*
4. The poster must be flat, no 3-D objects.
5. Poster size must be between 8.5" x 11" and 22" x 28".
6. Any medium may be used, including paint, crayons, colored pencils, charcoal and paper. No collage or montage. Computer generated artwork is not allowed. Clip art is not acceptable.
7. One poster per student.
8. The poster must be the original artwork of the student.
9. Entry deadline: See Local Rules.
10. Posters will be judged on the following criteria:
 - ◆ Relevance to contest theme (*Water is Life*)
 - ◆ Conservation message
 - ◆ Visual effectiveness
 - ◆ Originality
 - ◆ Overall appeal



Judges at the State level will represent the State level sponsors: the NJ Association of Conservation Districts, the State Soil Conservation Committee of the NJ Department of Agriculture, USDA-Natural Resources Conservation Service, and Rutgers Cooperative Research and Extension. **Decisions of the judges are final and all entries become the property of the contest sponsors.**

Soil Conservation Districts (SCD) are special purpose subdivisions of the State. In cooperation with the State Soil Conservation Committee, they are empowered to conserve and manage soil and water resources and address stormwater, soil erosion, and sedimentation problems that result from land disturbance activities. There are 15 SCDs in New Jersey.

In response to growing public concern for water quality, our conservation districts have become the primary local governmental agencies responsible for controlling nonpoint sources of pollution associated with agriculture, construction and mining. The technical services of the USDA, Natural Resources Conservation Service and other resource agencies are made available through the districts.
